1. The promotion is authorised under NSW Authority: TP/01559
2. The promoter is Sutherland United Services Club Ltd t/a trading as Club on East ABN 79 001 028 771.
3. The WIN A 9K EBIKE VOUCHER PROMOTION is open to financial members of Sutherland United Services Club Ltd. The promotion is not open to any member whilst their membership is suspended.
4. The following persons are not eligible to participate in the promotion or win:
 - (a) Club officers and their spouses; executives and their spouses; other employees - Club directors and their spouses or auditors and their spouses; Club executives and their spouses and other Club employees;
 - (b) Contractors directly involved in the promotion - Officers and employees of suppliers or contractors to the Club, who are directly involved in any aspect of the promotion.
 - (c) People who work on the Club's premises - Persons whose usual place of work is within premises owned by the club.
 - (d) People working at the Club - Persons employed by any other supplier or contractor of the Club, club contractors and their employees.

TICKETS

Entry tickets will be printed from one of the authorised printers at the main bar, cocktail bar, function room bars or bistro point of sale printers when members present their membership card for food and beverage purchases. Only these such tickets are eligible.

HOW TO ENTER

One (1) right of entry ticket for every \$10.00 accumulated spend at the main bar, cocktail bar, function room bars or bistro for food and beverage purchases. Entry tickets are to be placed in the barrel provided.

HOW THE PROMOTION WORKS

- Every Thursday during the promotional period at 6.30pm (prior to major draw night) one entry ticket will be drawn out of the entry barrel. In addition, every Thursday at 7.30pm during the promotional period (prior to major draw night) one entry ticket will also be drawn out of the barrel. The first member who is drawn out of the barrel at these minor draws and presents themselves within four minutes of the announcement will then select one envelope. Inside the envelope contains a number. Whichever number the member receives will represent the position in the major draw to try their key to the WIN A 9K EBIKE VOUCHER PROMOTION padlock on the 23rd May 2024. The second member who is drawn out of the barrel in the minor draws and presents themselves within four minutes of the announcement will also then select one envelope. Inside the envelope contains a number. Whichever number the member receives will represent the position in the major draw to try their key to the WIN A 9K EBIKE VOUCHER PROMOTION padlock on the 23rd May 2024.

OFFICIAL

- For first eight (8) weeks the minor draws will occur weekly on Thursday nights, then on the night of the major draw Thursday 23rd May 2024 two (2) more members at 6.30pm will be drawn out to select their envelopes (present themselves within four minutes of the announcement). Two (2) more members at 7.30pm will be drawn out to select their envelopes (present themselves within four minutes of the announcement).
- Members who are drawn from the entry barrel will be permitted a maximum of two keys to unlock the padlock and win the WIN A 9K EBIKE VOUCHER PROMOTION. If a member is drawn out who has previously been drawn and registered twice to unlock the padlock, then another member name will be drawn from the barrel until there are 20 positions holding eligible keys.
- To determine the winner of the WIN A 9K EBIKE VOUCHER PROMOTION each person having secured a number in a minor draw will come forward in the order revealed by the number in the envelope, select a key and try their key in the padlock. This will continue until the winner opens the padlock.

CONDITIONS OF ENTRY

- The WIN A 9K EBIKE VOUCHER PROMOTION is only open to financial members of Sutherland United Services Club Ltd. However, the promotion is not open to any member whilst their membership is suspended.
- Members will only present their own member card and have their member card swiped at the main bar, cocktail bar, function rooms or bistro to receive one (1) entry ticket per \$10 accumulated spend. Members do not receive entry tickets for pre- approved bar or food accounts (dry till account).
- The entry barrel will be located on the main ground floor area of the club as determined by club management.
- The barrel will be emptied after every Thursday night minor draws and these tickets will no longer be used for the promotion.
 - Members must be present on the club licenced premises at the start of the draw every Thursday the minor draw takes place or on the final night of the major draw 23rd May 2024 to claim their prize.
- Members must present their current financial membership card and proof of identity prior to selecting their envelope on the minor draw night or major draw night. The current financial membership card must match the name and membership number on the entry ticket.
- No further entries will be accepted into the entry barrel after 7.30pm on the 23rd May, 2024. If for any reason a member, on the night of the major draw, forfeits their position in

the major draw on the 23rd May 2024 a replacement member will be drawn from the barrel on the night of the major draw.

- There is no limit to the number of entry tickets (placed in entry barrel) per member during the promotion.
- Prior to awarding the major prize, the promotion host will request the winner to provide their current membership card and proof of identity (drivers licence, photo card or passport or acceptable forms of identification).
- Decisions of the management and promoter are final. No correspondence will be entered into.
- Only the member in attendance on the major draw, who has been drawn from the barrel from a minor draw, and received a number for their position in the final major draw is eligible to take part in the final WIN A 9K EBIKE VOUCHER PROMOTION draw (major prize) on 23rd May 2024.
- Members will be notified by in house public address system. The Club is not responsible for members being located in areas within the Club's premises in which PA announcements are not able to be heard, nor for the audible integrity of those announcements.

- All tickets must be the original tickets issued by an authorised club printer and legible with the correct information. Any tickets not considered by the management to not be original or legible will be invalid at the club management's sole discretion. Such invalid tickets will be ineligible to win the major prize. No correspondence will be entered in to on this decision to exclude a ticket, and management's decision is final.
- If the successful member fails to present himself or herself to the person who conducted the draw within 4 minutes of the announcement, a further draw will take place and the process will continue until a successful member presents himself or herself.
- The promoter reserves the right to cancel, terminate, modify or suspend the promotion subject to any written directions from the NSW Office of Liquor, Gaming and Racing.
- The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to)

health or COVID shutdown, technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.

- The Club's promotional areas (for announcements of all draws) are as determined by the Club in its discretion. It is the responsibility of the members to listen for announcements for the draws. Function rooms if in use for a private event at the time of the draws will be excluded. The Club car park does not form part of the Club's premises for the purposes of Club promotions.
- The prize will not be awarded to a member or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction or fraudulent activity.
- The Club determines the designated clock from which draws are timed.
- The major prize is not transferable to cash. E-Bikes on display at the club premises are for display purposes only.
- The major prize must be collected within 14 days at a location notified in advance by the club.
- A person by claiming or accepting the prize agrees that the Club may use their name, suburb, photograph, image and likeness for the purpose of promoting the Club including on social media and agrees to co-operate with the Club to allow their photo to be taken for those purposes.
- Neither the Club nor any of its officers, employees, contractors or agents, has any liability for any loss or damage of any nature or for injury or death, sustained in connection with the promotion or any prize, except any minimum liability which cannot be excluded by law (if any).
- No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand and accept the way in which the promotion operates and these conditions.
